## Pre-paid Debit Card Parking Agreement

Zions Securities Corporation (ZSC) grants to Parking Patron the right to park one vehicle in one parking space in the specified parking facility upon availability (Parking Right), and will issue Parking Patron one (1) parking access card (Card) for the Parking Right.

The Parking Right will become effective on \_\_\_\_\_, \_\_\_\_\_ and will remain active for two months from the last use of the debit card. If Parking Patron fails to use the Card for a period of two months, the Card will be deactivated. Parking Patron will pay \$5 as a reactivation fee to ZSC to reactivate the Card. The term of this Agreement is month-to-month and ZSC reserves the right to terminate the Parking Rights with thirty (30) days written notification.

Parking Patron will pay \$10 for the cost of the card in addition to the cost of the Parking Rights credited to the Card. Parking Patron assumes all risk of loss or damage to the Card, and ZSC will not replace lost or stolen Cards nor refund the value of any balance remaining on the Card.

Parking Patron agrees to pay ZSC the amount set forth herein as a pre-paid amount for the Parking Right. The pre-paid amount shall be applied toward the charge for the use of the Parking Right. If the pre-paid amount is depleted, Parking Patron will pay any outstanding charges at the parking exit gate. ZSC reserves the right to adjust the hourly rate for the use of the Parking Right. ZSC will use commercially reasonable efforts to notify Parking Patrons of any rate adjustments. The Card shall be terminated one year after the last use of the Parking Right and Parking Patron agrees that any unused amount on the Card at that time shall for forfeited. **\*\*\*No refunds, credits or allowances will be granted for non-use of the Parking Right.\*\*\***

Parking Patron authorizes ZSC to deduct from the balance on the Card any charges that should have been charged to the Card (i.e., gate malfunctions, improper use of the Card, Parking Patron circumvents the access system, etc.).

Neither ZSC nor the property owners assume any responsibility whatsoever for loss or damage of the vehicle or its contents however caused, and Parking Patron releases ZSC and the property owners for any such loss or damage. Vehicles should be locked and valuables should not be left in the vehicle.

Parking Patron agrees to abide by any and all regulations pertaining to the use of the facility as may, from time to time, be prescribed by ZSC, and further agrees to park where designated by ZSC. Any violation of the regulations will result in immediate termination of the Parking Right and the forfeiture of any balance remaining on the Card.
