1 Initial Zions Securities Corporation grants to the above cardholder one parking right in the specified parking facility. Those privileges will become effective on _____, _____. The term of the Agreement to be one month, automatically renewable each month upon the timely receipt of the prevailing fee to Zions Securities Corporation. Cardholder will be charged a full month for parking started on or before the 15th of each month. Parking started after the 15th of the month will be charged half of the monthly charge. Zions Securities Corporation reserved the right to terminate parking privileges with thirty (30) days written notification.

2 Initial Parking Patron agrees to pay Zions Securities Corporation \$_____ per month per parking right as rental for said parking privilege by the 1st day of each month for which the card is used. If payment is not received by that date, **the parking access card will be deactivated and will be subject to a \$15 reactivation charge per card.** If the card is deactivated for non-payment, the account must be paid in full **before** the card will be reactivated. Parking Patron will be responsible for all rental charges incurred until written notification of cancellation is received by Zions Securities Corporation. *****No refunds, credits or allowances will be granted for absence, vacation or other non-use of parking rights.*****

3 Initial Zions Securities Corporation reserves the right to adjust the monthly rental for said parking right annually. Notification will be give prior to said adjustment's).

4 Initial Parking Patron will be issued a parking access card for which there will be a \$10 card fee which must be paid in full before the card will be activated. This fee will not be refundable should the Parking Patron cancel the parking agreement. Parking Patron agrees to pay an additional \$10 non-refundable charge for replacement of lost or stolen cards.

5 Initial Neither Zions Securities Corporation nor the Property Owners assume responsibility whatsoever for loss or damage of the vehicle or its contents however caused. Vehicles should be locked and valuables should not be left in the vehicle.

6 Initial Parking Patron agrees to abide by any and all regulations pertaining to the use of the facility as may, from time to time be prescribed by Zions Securities Corporation, and further agrees to park where designated by Zions Securities Corporation. Any violation of said regulations will result in immediate termination of parking right.
